#### In Europe With Own N-Weapons

Paris: France is willing to discuss extending the protection afforded by its nuclear arsenal to its European allies, Presi dent Emmanuel Macron said Wednesday, as the continent scrambles to fend off heightened Russian aggression and di-minishing US support. France and Britain are the only two countries in Europe with their own nuclear weapons; only France is in the EU. Russia and the US are also nuclear powers

Our nuclear deterrent protects us — it is comprehensive, sovereign and French through and through." Macron said in a televised address that was mostly devoted to the war in Ukrai ne and Europe's safety "Since 1964, it has played an explicit ro le in preserving peace and secu-rity in Europe." "I have decided to open the strategic debate on protection through deterrence for our allies on the European continent," Macron added.

Macron is a staunch sup-porter of the EU who has argued for years that it needs to bol ster its defences and have more "strategic autonomy" from the US. He had floated similar ide as before. In 2020, well before Russia's invasion of Ukraine, he expressed support for a "strategicdialogue" with European partners "on the role play ed by France's nuclear deterrence in our collective security" At the time, those ideas had received little traction with France's allies, many of whom

#### Ukraine opposition rejects wartime polls as Trump officials meet Zelensky rivals

krainian opposition leaders have dismissed the idea of holding a vartime election, after a media report of contacts between them and US officials and in the wake of President Trump calling his Ukrainian counterpart Volodymyr Zelensky a "dictator" for not holding one. Former Ukrainian president Petro Poroshenko said on Thursday his team was working with US "partners" to maintain support for Ukraine — but he added that he was opposed to a wartime election. In a written statement published on Telegram, Poroshenko said elections should only happen after peace had been established and that a vote sho uld take place no later than 180 days after the end of the war. Yuliia Ty moshenko, another opposition leader, said her team "is talking with all our allies who can help in securing a just peace as soon as possible," and said that elections should not take place before this had been achieved. Politico reported on Wednesday that four senior members of Trump's entourage had held discussions with some of Zelensky's top political opponents. The talks focused on whether Ukraine could have quick presidential elections, according to the report. REUTERS

Now, though, US President Trump's decisions to drop sup port for Ukraine, pull back US's traditional security blanket in Europe and pressure allies to spend more on defence have forced the continent to rapidly ret hink its security architecture.

'Micron', Russia warns Macron not to threaten it

Moscow: Russia warned President Macron Thursday not to threaten it with nuclear rhetoric and, mocking his height by calling him 'Micron', ruled out European proposals send peacekeeping forces from Nato members to Ukraine.

The Kremlin said Ma-cron's address to the nation on Wednesday was extremely confrontational and that he wanted the war in Ukraine to continue. "This (speech) is, of course, a threat against Russia," foreign minister Sergei Lavrovsaid. "Unliketheirpredecessors, who also wanted to fight against Russia, Napols on, Hitler, Mr Macron does not act very gracefully, because at least they said it bluntly: 'We must conquer Russia, we must defeat Russia'."

mmigration attorneys and experts have allayed fears Lof existing EB-5 investors and of those who are contemplating opting for this investment-linked green card.

US commerce secretary Howard Lutnick had indicated, during an announcement of the Gold Card initiative. that it would replace the existing EB-5 programme, raising concerns of an executive order to end it abruptly.

But immigration experts explained that in 2022 Cong-

ress reauthorised the EB slative action, an unlikely sceprogramme through Sept 30, 2027, by passing the EB-5 Reform and Integrity Act (RIA), which contains grandfather provisions protecting investors who file EB-5 applications before Sept 30, 2026 from any future lapses in the programme. Kripa Upadhyay, immigration attorney said, "Trump cannot unilaterally end the EB-5 programme. It was created by Congress in 1990 and is codified in the Immigration and Nationality Act. Any attempt to eliminate or replace it requires legi-

nario in a divided Congress."

Of late, the EB-5 programme has caught the attention of H-1B holders already in the US, who are tired of waiting for an employment-linked card. It is also popular among rich Indians who want their children to have a future in America. For Indians, the entire process of obtaining an unconditional green card under the EB-5 can take between 6-7 years, or on a more conservative estimate up to 10 years.

Post Trump's announcement of a Gold Card, several 

who had invested feared that they would not get a green card, as this programme would be terminated. An investment of \$800,000 for projects in Targeted Employment Areas, which are rural and high-unemployment areas, and infrastructure projects, or \$1.05 million if located elsewhere is not cheap. even if relatively smaller than the \$5 million requirement for the proposed Gold Card.

Some investors are worried that the Trump administration will order the USCIS to reduce or completely pause the processing of EB-5 petitions.

#### India bought 112 bn euro worth of Russian oil since Ukraine war

NEW DELHI, Mar 6 (PTI)

INDIA, the world's third largest oil consuming and importing nation, spent 102.5 billion euro (about Rs 1.5 lakh crore) on buying crude oil from Russia since the start of the Ukraine war, a huropean think tank said on Thursday.

The Centre for Research on Liverment Clean Air (CREA) released a report on payments to Russia for fossil fuels since February 24, 2022.

"According to our estimates, since the beginning of the war, Russia earned EUR 835 billion in revenue from fossil fuel exports," it said.

China was the biggest buyer of Russian fossil fuel at EUR 235 billion (made up of EUR 170 billion for oil, EUR 34.3 billion for coal and EUR 30.5 billion for gas).

India, according to CREA, bought fossil fuel worth EUR 205.84 billion from Russia from the beginning of the war until March 2, 2025. This comprised EUR 112.5 billion (USD 121.59 billion) for purchase



of crude oil, which is refined into fuels like petrol and diesel at refineries, and EUR 13.25 billion for coal.

India, which is more than 85 per cent dependent on imports to meet its crude oil needs, spent USD 232.7 billion on crude imports in 2022-23 (April 2022 to March 2023) and USD 234.3 billion in 2023-24. In the first 10 months of the current fiscal, it spent USD 195.2 billion.

India, which has traditionally sourced its oil from the Middle East, began importing a large volume of oil from Russia soon after the invasion of Ukraine in February 2022. This is primarily because Russian oil was available at a significant discount to other international benchmarks due to Western sanctions and some European countries shunning purchases.

This led to India's imports of Russian oil seeing a dramatic rise, growing from less than 1 per cent of its total crude oil imports to a staggering 40 per cent in a short period.

Some of the refineries in India turned Russiancrude oil into fuels like petrol and diesel which were exported to Europe and other G7 countries, according to CREA.

Latest sanctions by the US have, however, led to a fall in imports after India shunned cargoes in sanctioned ships or insuranced by banned entities.

Russia, however, continues to be India's top oil source. India imported 1.48 millionbarrels per day (bpd) of crude oil from Russia in February, against 1.67 million bpd in the previous month.

#### China tones down 'READY TO EIGHT WITH US' remark

BEIJING, Mar 6 (PTI)

DAYS after its assertion to fight trade or "any other type" of war with the US, China on Thursday toned down its stand saying that no such wars should be fought because they cannot be on

"The US must no longer seek to contain or go after China in the name of strategic competition," Foreign Ministry spokesman Lin Jian told the media here responding to US Secretary of Defence Pete Hegseth's remark that his country doesn't seek a war with China, but will rebuild the military and prepare for war.

"We've always held the clear cut view that whatever kind of war it is, a tariff war or a trade war, a cold war or a hot war, they should not be fought and cannot be won," Lin said. In contrast, on Tuesday Lin



had said: "Let me reiterate that intimidation does not scare us. Bullying does not work on us. Pressuring, coercion or threats are not the right way of dealing with China. Anyone using maximum pressure on China is picking the wrong guy and miscalculating."

"If the US has other agenda in mind and if war is what the US wants, be it a tariffwar, a trade war or any other type of war, we're ready to fight till the end," he said, replying to a question on US tariffs on Chinese goods.

Reacting to Lin's comments, Hegseth said on Wednesday on Fox News: "Those who long for peace must prepare for war, [and] that's why we're rebuilding our military. That's why we're establishing deterrence."

President Donald Trump understands peace comes through strength, and he also has a good relationship with the leader of the Chinese Communist Party, Hegseth's comments posted on the US Defence Department website on Wednesday said.

He said the US is not actively seeking conflict with China. "We don't seek that war," Hegseth said. "But my job as Secretary of Defence is to make sure we're ready. [So], we need the defence spending, the capabilities, the weapons and the
